Committee Reports

Fundraisers — Joyce Kelly

- We have a Chipotle fundraiser organized by Stacy Koelfgen coming up on 2/7, the evening of the Niwot basketball games which are away. Grab some burritos and head to the game!
- We need to know about team fundraisers ahead of time. Plus, it will help us to promote them.
- New ideas for fundraisers—Texas Hold ‘Em Tournament; Jen Orvis suggested a partnership with breweries (a Booster Club in Loveland does this)—partner with Brew Hop or Oskar Blue (owners have a student here).

School Store — Kaydene Hubert for Paula Nelsen

- We are gearing up for the Silver Creek Open House on 1/30.
- Last year, we sold \$1,300 in merchandise. We would like to boost sales this year.
- The School Store is open every other Thursday until after Spring Break due to slow sales at this time of year.
- We expect to get pop sockets in this week or next.
- We are still taking online orders.
- Flannel pj bottoms and shorts were big sellers.

- We have hit a flat spot and still have ~130 members.

Concessions—Kaydene Hubert

- We reached out to Carrie Adams and are considering having a group of SCLA students run Concessions for their Capstone Project. Kaydene will mentor them in the process to teach them about budgets, invoices, supplies, volunteers, etc.
- Concessions this year have been hard. The most recent Girls’ Basketball game brought in just \$94.75 (volunteer only) and Boys’ Basketball just \$347 (paid volunteers).
- On the spreadsheet, if teams have been assigned a shift, an individual cannot edit or add her/his name to it. Parent reps for those teams keep track of their volunteers. An individual can only add his/her name to volunteer-only shifts.
- Thanks to Cheer for picking up both the Girls’ Tennis and Girls’ Golf shifts recently.
- Joyce mentioned that we would like to have limited Concessions starting this Spring for Baseball and Girls’ Soccer. Dani Olinger volunteered her wagon.
- Cheer sent their girls into the stands at a recent basketball game with popcorn and drinks. It worked great!

After-Prom—Lora Noesen

- The committee has started meeting.
- Prom tickets will go on sale on 3/18/19. The Prom will be held at Brookside in Berthoud on 4/13/19.
- This year’s After-Prom will be held at Silver Creek (alternating off-site and on-site) from 11 PM to 2 AM.
- The themes are a PJ Party and Carnival.
- There is no fee to attend After-Prom.
- Breakfast will be served (looking at Santiago’s burritos, juice, donuts, Einstein Brothers bagels, etc.).
- There will be outside entertainment. The idea is to have a professional entertainer until 1 AM to encourage kids to stay. Some ideas are a hypnotist, a comedian... The committee is currently getting references from other schools. They will also check with the Student Senate and Cindi Lindsey’s Prom Committee to get an idea what the students want.

- We will need a lot of volunteers! And, there is still time to join the After-Prom Committee.
- The committee is also looking for sponsors and donations to offset the cost. Donations can be made at the RABC web site.
- Per Kaydene, the Ed Foundation and SCOPA are checking with their Boards, but should be able to donate again this year.

New Business

By-Laws—Kaydene Hubert

- Everyone agreed to an oral vote.
- In the oral vote, everyone approved and no one opposed the revised By-Laws.
- In discussing the By-Laws, the Board noticed that they state that Coaches and Parent Reps are supposed to provide a list of the financial costs and lifespan of equipment for running their programs (Section 10). This list would be helpful for planning purposes.
